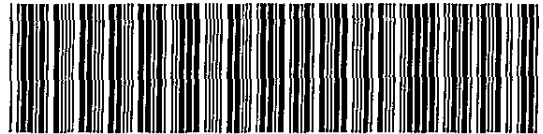

ARTICLE I of the Articles of Organization filed on December 16, 2002 with the Florida Secretary of State's office be amended to read as follows:

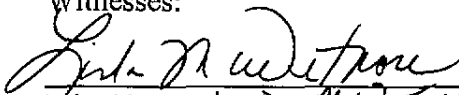
"ARTICLE I - NAME:
