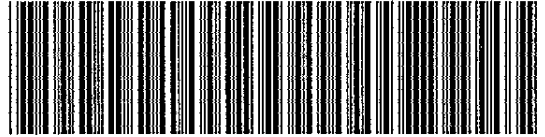

The net assets of the organization remaining after closing all business operations have been distributed among its in accordance with their respective rights and interests.


