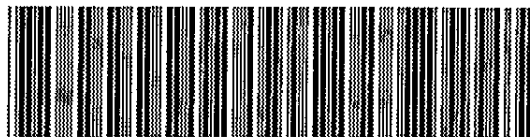



The period of duration for Racing With JD, LLC shall be perpetual commencing as of the date of filing of these Articles with the Florida Secretary of State.



Additional members may be admitted to Racing With JD, LLC only upon the unanimous written consent of the existing member(s).


**ARTICLE VII - MEMBERS' RIGHTS TO CONTINUE BUSINESS**
