ARTICLES OF ORGANIZATION

OF

ARTICLE I
NAME

The name of this Limited Liability Company is dadsland, L.L.C.

ARTICLE II
DURATION

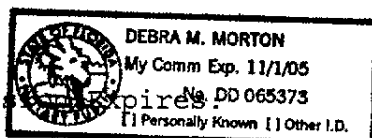

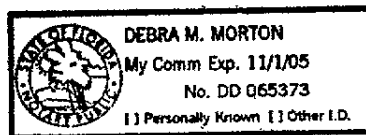
