# ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608 hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be CTH ENTERPRISES, LLC, ("Company").

#### **ARTICLE 2 - ADDRESS**

#### **ARTICLE 4 - DURATION**



#### ARTICLE 7 - ADMISSION OF NEW MEMBERS
