
1. The name of the Limited Liability Company: COMMONWEALTH FINANCIAL, L.L.C.

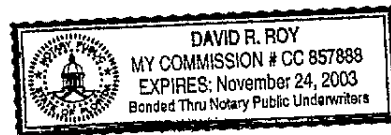


