

### ARTICLES OF ORGANIZATION

#### OF

## D & D ASSOCIATES LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be **D & D ASSOCIATES LLC**, ("Company").

#### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 5528 Via the La Plata Circle, Delray Beach, Florida 33484 and the mailing address shall be the same.
