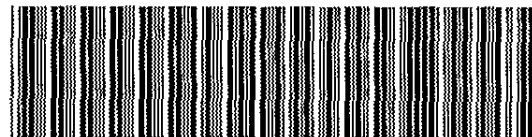

The mailing address and street address of the principal office of the Limited Liability Company is 4054 Beaver Lane, Suite 1, Port Charlotte, Florida 33952.

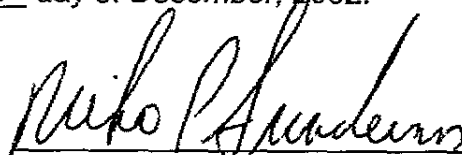
