MANAGEMENT**

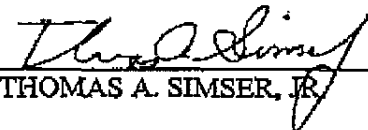
The Limited Liability Company shall be managed by the sole Member of the Limited Liability Company as provided in the Limited Liability Company's Operating Agreement.
