ARTICLE III - INITIAL REGISTERED OFFICE AND AGENT

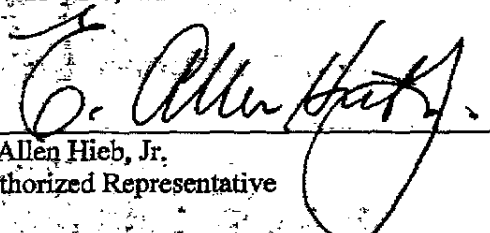

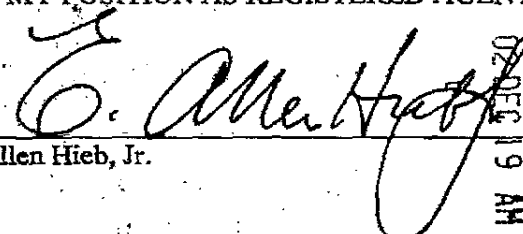
