ARTICLES OF ORGANIZATION OF JOHN L. DAVIS, LLC

The undersigned, who intends to form and create a Limited Liability Company, as defined in Chapter 608 of the Florida Statutes, does hereby state and certify the following:

- The name of the Limited Liability Company shall be JOHN L. DAVIS, LLC.
- 2. <u>Duration of Company</u>. The company shall have perpetual duration.
- 3. Principal Office. The mailing address is 13472 Troon Trace Lane, Jacksonville, Florida 32225-4917, and street address of the principal office of the Limited Liability Company is c/o John L. Davis, 13472 Troon Trace Lane, Jacksonville, Florida 32225-4917.
