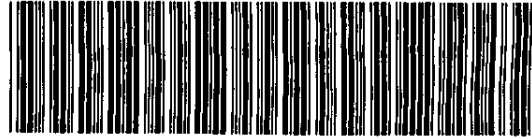

The undersigned as the sole member of the LLC does hereby restate the Articles of Organization by deleting all terms and provisions of said Articles of Organization and substituting the following provisions.

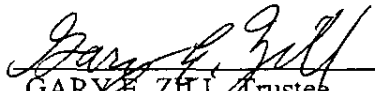

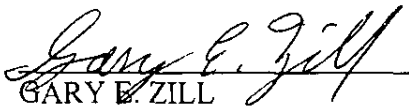
