**ARTICLES OF ORGANIZATION
OF
KALIEDOSCOPE COUNSELING SERVICES, P.L.**

The undersigned, for the purpose of forming a Professional Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608 and the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I

The name of the Professional Limited Liability Company shall be **KALIEDOSCOPE COUNSELING SERVICES, P.L.** ("company"), and its purpose shall be to provide mental health services to the public and other purposes permitted by law.

ARTICLE II

ARTICLE III

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date if specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the company's operating agreement (hereinafter referred to as "regulations").

ARTICLE IV

The name and street address of the registered agent of the company in the state of Florida is: Scott Ryan, MSW, MBA, Ph.D., 2933 Tipperary Court, Tallahassee, Florida 32309.

ARTICLE V

The members of the company shall contribute to the capital of the company the cash or property as required by law.

ARTICLE VI

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members, or as otherwise provided in the regulations.

ARTICLE VII

Except as may be set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless 75% of the members of the company, other than the member proposing to dispose of his or her interest, approve of the proposed transfer by written consent.


ARTICLE VIII

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by majority vote of all the remaining members.

ARTICLE IX

The company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. The name and address of the initial manager of the company is: **Scott Ryan**, MSW, MBA, Ph.D., 2933 Tipperary Court, Tallahassee, Florida 32309.

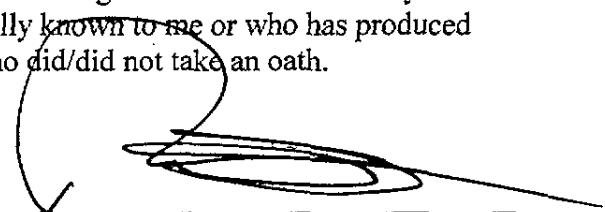

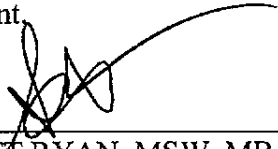
