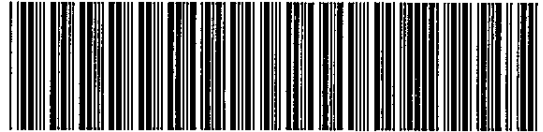

**ARTICLES OF ORGANIZATION
OF

ARTICLE 1: NAME

The name of the limited liability company shall be **Lahoud Opals, LLC**.

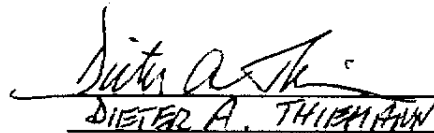
