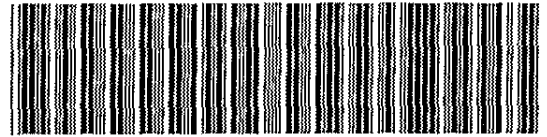



The initial registered agent is Dock A. Blanchard, Esquire. The registered agent may be changed at any time by a vote of the members without an amendment to these Articles.


