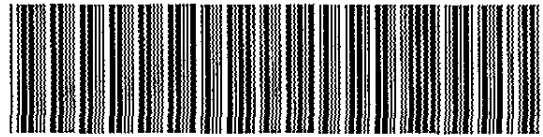

FLORIDA LIMITED LIABILITY COMPANY

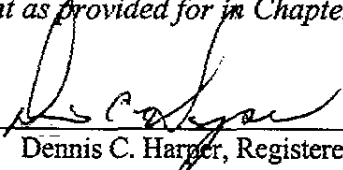
