#### PLAN OF MERGER

The following plan of merger, which was adopted and approved by each party to the merger in accordance with section 607.1107, is being submitted in accordance with section 607.1108, Florida Statutes.

FIRST: The exact name and jurisdiction of each merging party are as follows:

**THIRD:** The terms and conditions of the merger are as follows:

- (a) The operating agreement of the surviving limited liability company as it shall exist on the effective date of this Agreement shall be and remain the operating agreement of the surviving limited liability company until the same shall be altered, amended and repealed as therein provided.
- (b) The managers and/or the managing member\_of the surviving limited liability company shall continue in office until the next annual meeting of members and until a successor or successors have been elected and qualified.
- (c) This merger shall become effective upon filing with the Secretary of State of Florida, or if later, the effective date of the merger shall be as of the close of business on December 31, 2002.

All property, rights, and every other interest of the surviving limited liability company and the merging corporation shall be as effectively the property of the surviving limited liability company as they were of the surviving limited\_liability company and the merging corporation respectively. The merging corporation hereby agrees from time to time, as and when requested by the surviving limited liability company or by its successors or assigns, to execute and deliver or cause to be executed and delivered all such deeds and instruments and to take or cause to be taken such further or other action as the surviving limited liability company may deem to be necessary or desirable in order to vest in and confirm to the surviving limited liability company title to and possession of any property of the merging corporation acquired or to be acquired by reason of or as a result of the merger herein provided for, and otherwise to carry out the intent and purposes hereof.
