### Article III. Amendment

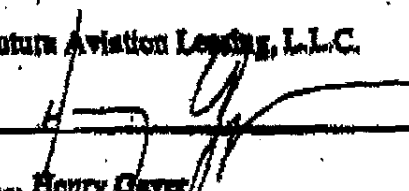
