ARTICLE I (Company Name) and ARTICLE II (Company Address)

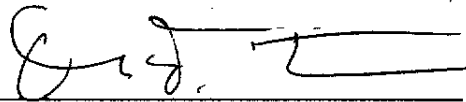

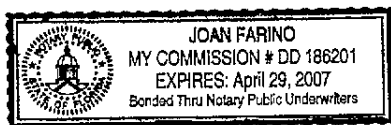

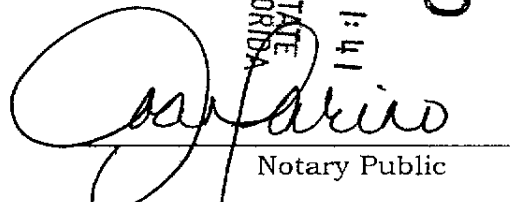
