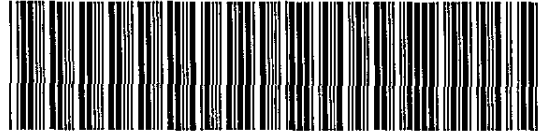

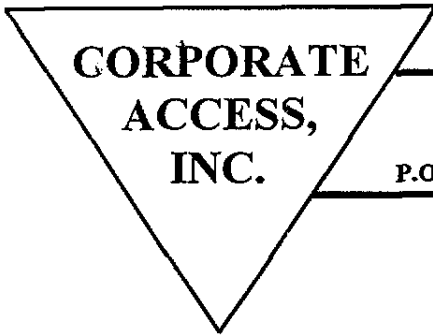


**ARTICLE III


