The undersigned, being the Manager and a Member of a limited liability company to be organized under the Florida Limited Liability Company Act, adopts and submits the following Articles of Organization for such limited liability company.

**ARTICLE I  
NAME**

The name of the limited liability company (the "Company") shall be **TRAVIS PROPERTIES, LLC**, a Florida limited liability company.

**ARTICLE II  
PRINCIPAL PLACE OF BUSINESS**

**ARTICLE III

The initial number of Managers of the Company shall be one (1). The number of Managers may be decreased or increased in accordance with the terms of the Regulations.
