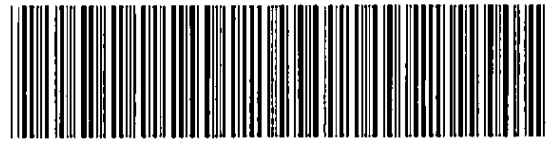

ARTICLE IV – OCCURRENCE THAT RESULTED IN DISSOLUTION


