#### ARTICLES OF ORGANIZATION FOR S.J. PARK INVESTORS, LLC. A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute, Section 608.401 et. seq., entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

- 1. NAME. The name of this company shall be S.J. PARK INVESTORS, LLC.
- 2. ADDRESS OF COMPANY. The mailing and street address of the principal office of the Company is 6167 Windlass Circle, Boynton Beach, Florida 33437.
- 3. REGISTERED AGENT AND OFFICE. The name and street address of the initial registered agent and office for the Company is as follows: ARTHUR R. ROSENBERG, located at 4875 North Federal Highway, 7th Floor, Fort Lauderdale, Florida 33308.
- 4. MANAGEMENT OF THE COMPANY. The business of the Company shall be managed by its members.
- 5. PURPOSE OF COMPANY. The Company is being formed to engage in any activity or business permitted under the laws of the United States and of the State of Florida and such other states in which the Company may engage in business.
- 6. REGULATIONS OF COMPANY.
