ARTICLES OF ORGANIZATION

OF

The undersigned, desiring to form a limited liability company under the provisions of Florida Statute 608, as amended, hereby sets forth the following:

ARTICLE I

Name

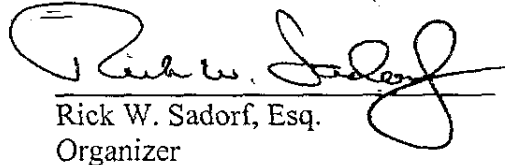

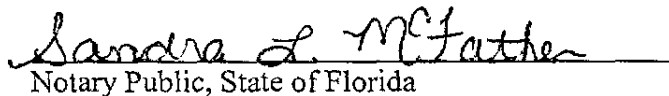

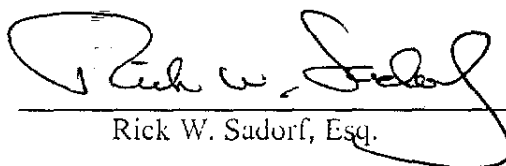
