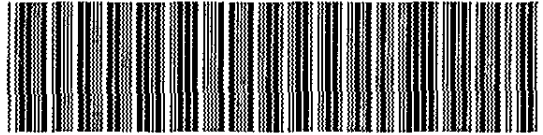

FIRST: The date of the filing of the Articles of Organization was 2 January 2003.


SECOND: The name of this Company shall be changed to **SAKAN ACCEPTANCE COMPANY, LLC**.
