WALL FAMILY TRUST, LLC****ARTICLE I****NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of this limited liability company shall be Wall Family Trust, LLC, and the mailing address and street address of its principal office shall be 99 Nesbit Street, Punta Gorda, Florida 33950, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

**ARTICLE II****PURPOSES AND POWERS**

#### ARTICLE IV

##### MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except in accordance with the provisions of the company's Operating Agreement.

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business in accordance with the provisions of the company's Operating Agreement.
