ARTICLE IV MANAGEMENT

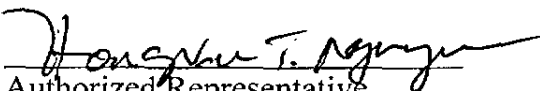

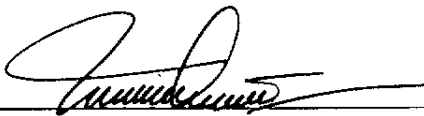
