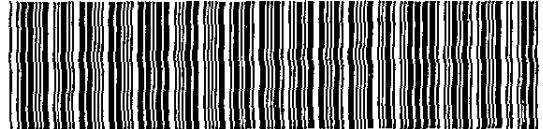

Pursuant to Section 608.411, Florida Statutes, as amended, set forth below are the Amended and Restated Articles of Organization of Squires Office, LLC, a Florida limited liability company (the "Company"):

WHEREAS, the original Articles of Organization of the Company were filed on January 3, 2003;

WHEREAS, the name and address of the initial registered agent were: Robert C. Bowling ("Bowling"), 1680 N.E. 135th Street, North Miami, Florida 33181.

WHEREAS, effective December 22, 2003, Bowling ceased to be a member of the Company, and transferred his entire right, title and interest in the Company to James J. Hurchalla ("Hurchalla"); and

WHEREAS, because Bowling has ceased to be a member of the Company, the name and address of the registered agent, and the address of the principal office of the Company, have changed; and

WHEREAS, the foregoing changes were approved by unanimous written consent of the members of the Company; and
