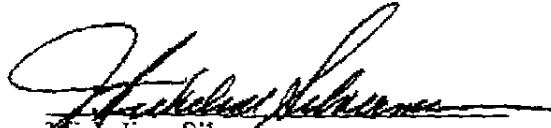

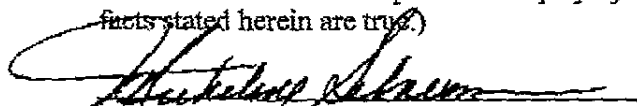
ARTICLE VII:

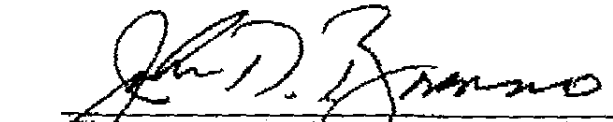
