

ARTICLES OF ORGANIZATION OF Global Insurance Management Company, L.L.C.

ARTICLE I

NAME

The name of the limited liability company shall be Global Insurance Management Company, L.L.C.

ARTICLE II

PURPOSES AND POWERS

The limited liability company is authorized to transact any business permitted by the laws of the State of Florida, as amended from time to time, for a limited liability company.
