#### ARTICLES OF ORGANIZATION OF STK MORTGAGE, LLC,

a Florida Limited Liability Company

The undersigned, being the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopt and submit the following Articles of Organization for such limited liability company:

#### ARTICLE I

The name of the limited liability company (the "Company") shall be STK MORTGAGE, LLC, a Florida limited liability company.

# ARTICLE II PRINCIPAL PLACE OF BUSINESS
