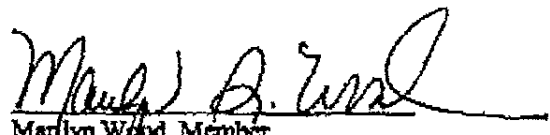
ARTICLE IV
