The name and street address of the registered agent of the Company in the State of Florida is: Steven Meister, 1901 NE 188th Street, North Miami Beach, Florida 33162

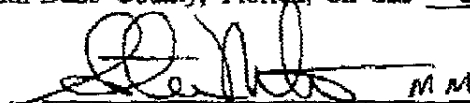
ARTICLE IV - ADMISSION OF ADDITIONAL MEMBERS

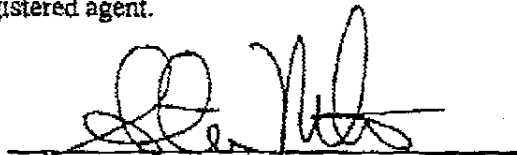
