

ARTICLES OF ORGANIZATION OF ZAC FURNITURE IMPORTS, LLC

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.

ARTICLE I

The name of this limited liability company is ZAC FURNITURE IMPORTS, LLC ("Company").

ARTICLE II
