ARTICLE I - Name:

The name of the Limited Liability Company is:

ARTICLE II - Address:

ARTICLE III - Duration:

ARTICLE VIII - Registered Agent



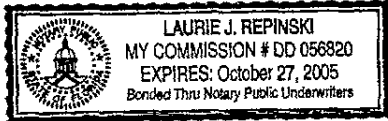
