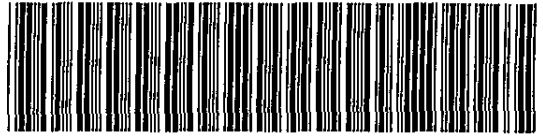




1. NAME. The name of the Limited Liability Company is *DENTAL ENERGY, LLC* (the "Company").


