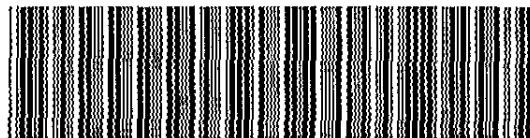

ARTICLES OF ORGANIZATION

Jerry D. Peterson Builder, LLC

A LIMITED LIABILITY COMPANY

(Pursuant to s. 607.407, Florida Statutes)


8. Additional Members. The names and addresses of additional members(s) are as follows:


