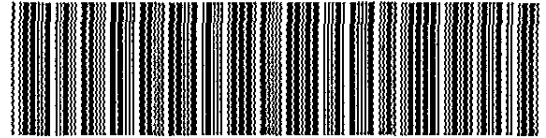

(Pursuant to s. 607.407, Florida Statutes)




