The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE 1 - NAME**

The name of the limited liability company shall be **LONGWOOD FOODS, LLC**, ("Company").

**ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 2401 West State Road 434, Suite 149, Longwood, Florida 32779 and the mailing address shall be Post Office Box 916555, Longwood, Florida 32791-6555.

**ARTICLE 3 - EFFECTIVE DATE**


