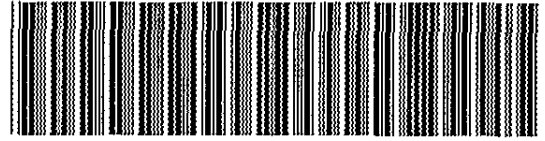




The period of duration for the Limited Liability Company shall be perpetual. The areas of practice of the Limited Liability Company are limited to the practice of law.
