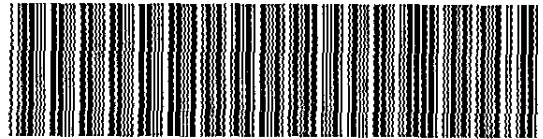

**ARTICLES OF ORGANIZATION
OF

The undersigned hereby forms and establishes a limited liability company pursuant to Chapter 608, Florida Statutes as follows:

ARTICLE I


ARTICLE VI
