**ARTICLES OF ORGANIZATION  
OF

**ARTICLE I  
NAME**

The name of this limited liability company is Three Belles, L.L.C., a Florida limited liability company (the "Company").

**ARTICLE II  
DURATION**

The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.


