ARTICLES OF ORGANIZATION

<u>OF</u>

THIRTY-SIX HUNDRED HOLDINGS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be THIRTY-SIX HUNDRED HOLDINGS, LLC ("Company"). The principal place of business of the Company in Florida shall be located at 1200 N. Federal Highway, Suite 312, Boca Raton, Florida 33432 and the mailing address shall be the same.

ARTICLE II - DURATION

ARTICLE IX - MANAGEMENT

The Company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
