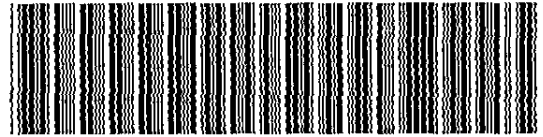

ARTICLES OF ORGANIZATION
BIG SCALE ENTERTAINMENT, LLC


