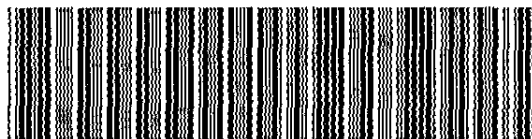

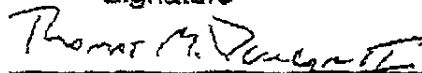
LIMITED POWER OF ATTORNEY

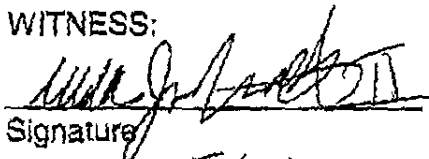

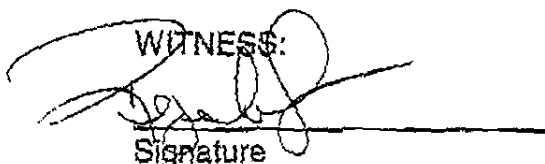

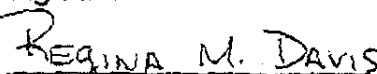
