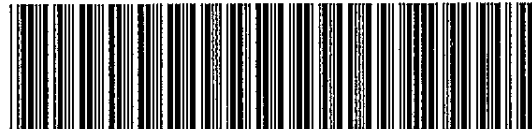



**ARTICLE V – Professional Limited Liability Company**


The limited liability company shall be a professional limited liability company
