**ARTICLES OF ORGANIZATION FOR FLORIDA
PROFESSIONAL LIMITED LIABILITY COMPANY**

The undersigned authorized representative, desiring to form a professional limited liability company pursuant to the provisions of the Professional Service Corporation and Limited Liability Company Act, hereby submits these Articles of Organization.

ARTICLE I - Name

The name of the professional limited liability company shall be: **MARLA K. MARTINI, C.R.N.A., P.L.**

ARTICLE II - Address

The mailing address of the principal office of the professional limited liability company shall be:

ARTICLE III - Effective Date

The professional limited liability company shall commence to exist on January 11, 2003.

ARTICLE IV - Nature of Business

The general nature of business to be transacted by the professional limited liability company, or the objects or purposes of the professional limited liability company, shall be as follows:

(a) To engage solely and specifically in the practice of nursing, specializing in anesthesia, through one or more duly licensed nurse anesthetists, and in the business of providing related nursing anesthesia services.

(b) To invest in real estate, mortgages, stocks, bonds or any other type of investments.

(c) To own real and personal property necessary for the rendering of the above professional services.

(d) In general, to have and exercise all powers conferred by the laws of the State of Florida upon professional service corporations, and to do any and all things hereinabove set forth to the same extent as a natural person might or could do.

ARTICLE V – Management

The professional limited liability company shall be managed by a Manager, and the name and address of said Manager are:

ARTICLE VI - Membership Units

The total number of membership units authorized to be issued by the professional limited liability company shall be 10,000 units, par value \$.01. Each of the said units shall entitle the holder thereof to one (1) vote at any meeting of the members. All or any part of said units may be paid for in cash, in property, or in labor or services at a fair valuation to be fixed by the managers of the professional limited liability company at a meeting called for such purposes. All membership units then issued shall be paid for and shall be nonassessable. The professional limited liability company elects to have preemptive rights governed in accordance with Section 607.0630 of the Florida Statutes. Membership units shall be issued in accordance with the operating agreement of the professional limited liability company.

ARTICLE VII - Ownership

The initial members of the professional limited liability company shall be those members identified in the operating agreement of the professional limited liability company, unless one or more additional members are admitted in accordance with such operating agreement.

ARTICLE VIII - Admission of Additional Members

Additional members may be admitted in accordance with the operating agreement of the professional limited liability company. However, no individual may be admitted as a member unless such individual is duly licensed and otherwise legally authorized to render nursing services, specializing in anesthesia, as a nurse anesthetist, and no entity may be admitted as a member unless such entity is a professional service corporation or a professional limited liability company that is duly licensed or otherwise legally authorized to render nursing services, specializing in anesthesia, through one or more duly licensed nurse anesthetists.

ARTICLE IX – Right of Members to Continue Business

Except as otherwise provided in the operating agreement of the professional limited liability company, the remaining member or members of the professional limited liability company, if any,


shall be entitled to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the professional limited liability company.

ARTICLE X - Registered Agent, Registered Office, and Resident Agent's Signature


