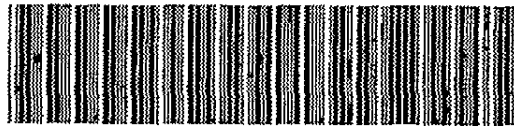


ARTICLE VI. REGULATIONS OF MANAGEMENT


