The following amendment to the Articles of organization was adopted by the limited liability company:

- I. ARTICLE I of said Articles of Organization which presently reads:

"The name of this limited liability company shall be ESTATE & WEALTH PLANNING ADVOCATES LLC."

shall be amended to read as follows:

**"The name of this limited liability company shall be ADVOCATES FOR ESTATE AND WEALTH PLANNING, P.L.C.**

- II. Article 6 - PURPOSES AND GENERAL POWERS shall be added to said Articles of Organization and shall read as follows:

**Article 6 - Purposes and General Powers**
