#### ARTICLES OF ORGANIZATION

OF

#### FLORIDA SURGICAL SPECIALTIES, LLC

#### ARTICLE I

#### NAME

O3 JAN 21 PM 1: 13
TALLAHASSEE, FLORIDA

The name of this limited liability company (the "Company") shall be FLORIDA SURGICAL SPECIALTIES, LLC and its mailing address is 10060 Bishop Lake Way, Jacksonville, FL 32256, and its principal place of business is 10060 Bishop Lake Way, Jacksonville, FL 32256.

#### **ARTICLE II**

#### COMMENCEMENT OF EXISTENCE

This Company shall commence existence on the date these articles of organization are filed with the Florida Department of State and shall have perpetual existence unless sooner dissolved in accordance with the Operating Agreement of the Company or according to law.

#### **ARTICLE III**

#### GENERAL PURPOSE: GENERAL POWERS

The general purpose of this Company shall be the transaction of any and all lawful business. This Company shall have all of the powers enumerated in the Florida Limited Liability Company Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law.

#### **ARTICLE IV**

#### INITIAL REGISTERED OFFICE AND AGENT

The Managers have sole authority to manage the Company and are authorized to make any contracts, enter into any transactions, and make and obtain any commitments on behalf of the Company to conduct or further the Company's business. Except as authorized by the Managers, no Member is an agent of the Company or has the authority to make any contracts, enter into any transactions, or make any commitments on behalf of the Company.

#### **ARTICLE VI**

#### **OPERATING AGREEMENT**

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the Managers.

#### **ARTICLE VII**

#### ADMISSION OF NEW MEMBERS

Additional Members may be admitted from time to time on such terms and conditions as determined by the Managers. No current Member has any preemptive rights.

#### **ARTICLE VIII**

#### DEATH, RETIREMENT, RESIGNATION, BANKRUPTCY, EXPULSION, DISSOLUTION OF MEMBER

In the event of the death, retirement, resignation, bankruptcy, expulsion or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the Managers may continue the business of the Company without a vote of the Members so long as there is at least one remaining Member of the Company.

#### **ARTICLE IX**

#### **AMENDMENT**

The right to amend or repeal any provisions contained in these articles of organization, or any amendment hereto, is conferred upon the Managers.

#### ARTICLE X

#### **HEADINGS AND CAPTIONS**

The headings or captions of these various articles of organization are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.
